U.S. Marriage License Fees

Sample of Fees from 50 States and District of Columbia

Marriage License issuance venues vary from state to state-- state issuance, county issuance, city/town issuance-- but in most states is a county function.

In many states, including Missouri, Marriage License fees vary from political subdivision to political subdivision due to local option fees.

In states with premarital counseling statutes, the Marriage License fee is higher for applicants who do not complete the counseling.
